Dear Mr. Gomberg:

Re: Sharon and Bill Shore

It has come to our attention that your clients, Mr. and Mrs. Shore, have given numerous interviews with the press and have as well re-established the web site www.lisashore.com. On the web site as well as in comments made to the media, Mrs. Shore particularly, has made statements designed to convey to a reasonable person that the nurses are in fact guilty of the conduct which gave rise to the charges and that this conduct caused the death of Lisa Shore. This is tantamount to an assertion that they are in fact guilty of the crime of criminal negligence causing death.

We feel strongly that these remarks as well as others made by your clients are libelous and can only be designed to further damage the nurses' reputations as well as to prejudice the discipline hearing into charges of professional misconduct currently before the College of Nurses. As a result, we are formally requesting that Mr. and Mrs. Shore close down this website and cease making remarks of the kind they are making in respect of both Anagaile Soriano and Ruth Doerksen.

In addition, we have reviewed a tape of the remarks made by both you and your client to Canada AM, a broadcast of CTV, in which you made a number of statements regarding the evidence called at the preliminary inquiry. For example, you stated that a number of witnesses were "not forthcoming". This clearly implies that witnesses withheld information when they testified under oath at the behest of the Crown. We remind you that a transcript of these proceedings can be obtained by you to inform yourself as to the actual


evidence and conduct of the witnesses. For your information, the transcript of the proceedings can be ordered from the Court Reporter, Ms Yolande Guerra Harrison, who can be reached at 416-327-5609. To the extent that both you and your clients are suffering from a misapprehension as to the facts insofar as neither of you attended at the preliminary inquiry, we would suggest that you inform yourself as to the true state of affairs before any further statements are made by either you or your clients. Finally, your comments seem particularly ill considered in light of the fact that Mrs. Shore's conduct profoundly affected the Crown's evaluation of her credibility in circumstances where she was an essential witness for the prosecution.

We trust that you will give this matter your urgent attention.
