**ORDER**

A interlocutory motion was brought on January 28th, 2002 by Ms. Sharon Shore requesting access to two Exhibits (3 and 4) which had been entered at a hearing convened on December 4<sup>th</sup>, 2001. This hearing had been convened to hear a motion for adjournment in the proceedings against the Members. The Exhibits at issue are two documents; (1) "Motion for Adjournment of Proceedings Regarding College of Nurses of Ontario and Ruth Doerksen, dated December 3<sup>rd</sup>, 2001 and (2) "Motion for Adjournment of Proceedings between College of Nurses of Ontario and Ana Galilea Soriano, dated December 3<sup>rd</sup>, 2001.

The panel members were provided with documents from defence counsel and from College counsel to be considered in the decision. A majority panel was convened on April 24<sup>th</sup> 2002, in person and through teleconference to deliberate, having considered the submissions by counsel.

**The panel grants the motion brought by Ms. Sharon Shore requesting copies of Exhibit #3 and Exhibit #4, said Motion(s) for Adjournment of Proceedings.**

The panel instructs Ms. Shore that these documents are confidential. They are to be used solely for her personal collection of documents and are not to be shared with members of the media or for any journalistic purpose, nor are they to be used in any way to obstruct the process of future proceedings.
